1. Political party leh candidate te tan campaign neih phal a ni tawh lo.
2. Constituency pawn atanga campaign tura lo kal, chu constituency a vote nei si lo te chuan constituency an chhuahsan tawh tur a ni. Amaherawhchu hei hian candidate leh election agent te leh party office bearer, state in-charge a ruat te chu a huam ve lo vang.
3. Aurinna (loudspeaker) hman phal a ni tawh lova, District Magistrate in khapna thupek Sec. 144 CrPC hmanga a chhuah chu zawm vek tur a ni.
4. Sec. 126A of the Representation of the People Act, 1951 in a sawi angin electronic Media/Social Media leh a tlukpui dangte ah Election kaihhnawih, mipui rilru sukthlek tidanglam thei thilte tarlan/chhuah phal a ni lo. Tin, hemi chhung hian mipui ngaihdan lakna 'Opinion Poll' siam leh 'exit poll' (Vote thlak zote kawmna/zirbingna atanga intlan result rinlawkna) neih loh tur a ni. Hei hian vote thlak tan hun atanga a zawh hnu darkar chanve thleng a huam ang.
5. Intlan ni (07.11.2023) leh a hma ni (06.11.2023)-a print media a political advertisement chhuah tur te chuan MCMC (Media Certification and Monitoring Committee) te phalna an la tur a ni.
6. Criminal Antecedent nei Contesting candidate leh Political Party-te an awm chuan Newspaper leh TV ah format pek tawh angin, Format C1 (Candidate tan) leh C2 (Political Parties) te tan, a vawithumna hi an la chhuah lo a nih chuan 05.11.2023 (Pathianni) tlai dar 4:00PM hma ngei a chhuah fel tur a ni.
7. Sec. 130 of the Representation of the People Act, 1951 in a sawi angin intlan ni ah hian polling station atanga metre 100 huamchhung ah vote dilna anga ngaih thei thil reng reng tih phal a ni lo.
